

Maths and how these particular subjects can be supported.

2. Safeguarding - This will cover legislation, agencies and procedures related to keeping children safe in all respects.
3. Communication - This will cover professional relationships and strategies to support appropriate behaviour in school.
4. Equality, Diversity and Inclusion - This will cover legislation and procedures in place to ensure equality of opportunity for all children. It will include work on supporting children with Special Educational Needs and Disabilities.
5. Schools as Organisations - This will cover roles and responsibilities in schools and the wider educational context.

Students will supplement their studies through a detailed reflective journal making links between theory and practice

What teaching methods will be used and will there be work outside of the class?

- The WEA tutor will use a range of different teaching and learning methods and encourage you and the group to be actively involved in your learning
- You may be asked to undertake additional work in your own time to support your learning
- You will be expected to carry out a range of activities in your own time

What kind of feedback can I expect from the tutor?

- A range of informal activities will be used by the tutor to see what you are learning which may include quizzes, question and answer, small projects and discussion
- You will have opportunities to discuss your progress with your tutor
- You will be encouraged to share your work with the group and discuss your learning
- You will be encouraged to consider other students work and give your opinions and suggestions
- A file of work will be kept which will help to record your progress
- There will be a number of tasks appropriate to your course such as written work, creating art or craft, video, photography or small projects. Some of these may be marked to help you progress

What else do I need to know? Is there anything I need to bring?

- A selection of materials and basic equipment will be provided but you are welcome to bring additional materials with you
- It would be helpful if you had access to the internet (Mobile phone, tablet or computer at home or through a library etc.)

Pre-course work, reading and information sources

- No pre reading is required but research on the subject on the internet or in the library may be helpful
