

By the end of the course I will be able to:

1. Identify and recognise from key examples influential architecture of the Italian Renaissance.
2. Name some with key publications on Renaissance architecture.
3. Consider how the buildings and publications of Renaissance Italy inspired the work of English architects and give examples of their influence.

What teaching methods will be used and will there be work outside of the class?

- The WEA tutor will use a range of different teaching and learning methods and encourage you and the group to be actively involved in your learning
- Presentations with images and colour notes provided for each session.

What kind of feedback can I expect from the tutor?

- A range of informal activities will be used by the tutor to see what you are learning which may include quizzes, question and answer, small projects and discussion
- You will have opportunities to discuss your progress with your tutor

What else do I need to know? Is there anything I need to bring?

- Nothing else is needed
