

What will I achieve?**By the end of the course I will be able to:**

1. recognise the major contributions that Haydn made in the development of late eighteenth-century European music;
2. understand the significance of Haydn's role in shaping English musical tastes;
3. appreciate why Haydn regarded England as 'the land of opportunity';
4. enjoy Haydn's music more fully.

What teaching methods will be used and will there be work outside of the class?

- The WEA tutor will use a range of different teaching and learning methods and encourage you and the group to be actively involved in your learning

What kind of feedback can I expect from the tutor?

- A range of informal activities will be used by the tutor to see what you are learning which may include quizzes, question and answer, small projects and discussion
- You will have opportunities to discuss your progress with your tutor

- It would be helpful if you had access to the internet (Mobile phone, tablet or computer at home or through a library etc.)
