### **What will I achieve?**

#### **By the end of the course I will be able to:**

1. Define the term 'musical genre'.
2. Explain how the musics of different cultures influenced each other.
3. Describe the importance of technology in 'pop' music (amplification, radio, electronic recording, television & video).
4. Show appreciation that, until the advent of recorded music becoming widely available, sheet-music sales made up the sales 'charts' or 'hit parade'.
5. Demonstrate an understanding of some music theory.

### **What teaching methods will be used and will there be work outside of the class?**

- The WEA tutor will use a range of different teaching and learning methods and encourage you and the group to be actively involved in your learning

### **What kind of feedback can I expect from the tutor?**

- A range of informal activities will be used by the tutor to see what you are learning which may include quizzes, question and answer, small projects and discussion
- You will have opportunities to discuss your progress with your tutor
- You will be encouraged to consider other students work and give your opinions and suggestions
