## Do I need any particular skills or experience?

- This session is for those with an interest in developing community interpreting skills. You will need a sound grasp of English as you will be required to speak, listen, read and write up to Level 1. This will be assessed through a task you will be asked to complete during this session.

## What will I achieve?

**By the end of the course I will be able to:**

1. Identify the Community Interpreting courses available
2. Identify the skills I have, need and will develop during a course
3. Agree whether I will be able to/ am ready to undertake an accredited course

4. Prepare for enrolment or referral to other learning opportunities

**What teaching methods will be used and will there be work outside of the class?**

- During the initial assessment you will be asked to complete a written task and will have a verbal conversation with a member of staff to discuss the course.

**What kind of feedback can I expect from the tutor?**

- Staff at the initial assessment will provide you with verbal feedback to help determine your next steps.
