

By the end of the course I will be able to:

1. Indicate reasons for and explain the diversity and uniqueness of the animal and plant world of the Russian Far East and adjacent regions.
2. Show how the wildlife of the region was affected by successive human migrations.
3. Explain how the USSR protected its wildlife, and indicate changes since 1991.
4. Suggest reasons for the threats faced by the natural world at different stages in the history of the Russian Far East.
5. Assess the reasons why the Russian Far East and the "Manchurian Region" have been a source of political dispute in the 19th and 20th centuries.

What teaching methods will be used and will there be work outside of the class?

- The WEA's digital learning platform, Canvas will be used to provide resources or to support lessons, enable assessment, provide learner feedback and for other activities for individuals away from the course. What kind of feedback can I expect from the tutor?

- A range of informal activities will be used by the tutor to see what you are learning which may include quizzes, question and answer, small projects and discussion
