Course Aim

The course is aimed at students who are interested in a career in community interpreting. It offers the opportunity for students who are speakers of other languages to learn about the role of a community interpreter.

Course Description

In this course you will learn about the roles and responsibilities of a community interpreter and the settings in which they work. You will also discuss the differences in public service provision between the UK and another country and learn about the dynamics of communities regarding access to public services. You will develop your knowledge of public service terminology and language difficulties which may arise in community interpreting situations.

What will I achieve?

By the end of the course I will be able to:

1. Identify the settings in which a community interpreter works
2. Appreciate the dynamics of communities regarding access to public services
3. Recognise basic public service terminology and the language difficulties which may arise in a community interpreting situation
4. Determine the differences in public service provision between the UK and another relevant country

What teaching methods will be used and will there be work outside of the class?

- You will be expected to carry out a range of activities in your own time

What kind of feedback can I expect from the tutor?

- You will be able to keep a record of your progress and achievement using photos, audio, text or documents uploaded into the WEA's digital learning platform, WEA Canvas.
- Your tutor will provide written, text and audio feedback recorded in WEA Canvas, WEA's digital learning platform.
- You will be able to keep a digital portfolio of your work on WEA's digital learning platform, Canvas.
- A range of informal activities will be used by the tutor to see what you are learning which may include quizzes, question and answer, small projects and discussion
- You will have opportunities to discuss your progress with your tutor
- You will be encouraged to share your work with the group and discuss your learning
- You will be encouraged to consider other students work and give your opinions and suggestions
- A file of work will be kept which will help to record your progress
