Course Aim

This course will identify and explore the lives and achievements of women who have acted as radicals in a range of different fields, showing how they changed the lives of people in their own time and their legacy today.

Course Description

Throughout history there have been women who have broken free of restrictive cultural and social expectations to behave radically. Together we will explore the lives and achievements of women in different times and places in the world, whose radical ideas and actions have changed their world and, in many cases, left a legacy which has provided freedoms and opportunities for us today.

By the end of the course I will be able to:

1. identify what makes a woman a radical and why she may become one
2. understand how and why women have had to overcome barriers because of their gender
3. appreciate the broad range of successes that women radicals have achieved in their time and place
4. recognise and appreciate the impact of women radicals on our own lives today

What teaching methods will be used and will there be work outside of the class?
