Course Aim

The course is a bridging course which helps ESOL learners with their understanding of basic food hygiene regulations and good practices as well as key vocab for the topic.

Course Description

This Food Hygiene course has been designed to help ESOL learners who wants to work in the catering industry understand their legal responsibilities and know what constitutes best practice in regards to controlling food safety hazards, controlling temperatures, food storage, food preparation, personal hygiene and premises cleaning.

By the end of the course I will be able to:

1. Understanding the information on food labels
2. Understanding the laws about food safety
3. Understand safe practices around food storage
4. Be aware of the importance of personal hygiene
5. Understand how to prepare food safely
